By the signature of its authorized representative below, the Applicant agrees to be bound by the terms hereof as well as the terms and conditions stated in the Articles of Incorporation and Bylaws (“Organizational Documents”), as amended and in effect on the date hereof, of the Trusted Computing Group ("TCG") as may apply to the Membership Classification selected above, copies of which are available for review at <http://www.trustedcomputinggroup.org>. To the extent that the Organizational Documents are amended, Applicant will be bound to such amendments only in accordance with the terms set forth in the Bylaws. Applicant is encouraged to review these materials prior to the execution of this Agreement.

Work Group access to Associate members is limited to involvement in only solutions-based groups. Solutions-based Work Groups are currently defined as the Trusted Mobility Solutions Work Group and the Trusted Multi-tenant Infrastructure Work Group.

No Membership Agreement is binding on TCG unless accompanied by the annual membership fee** (which fee may be deferred by action of the Board of Directors of TCG for up to 30 days from acceptance hereof) designated above for the particular class of membership selected and unless accepted by TCG. TCG reserves the right in its sole discretion, to accept or reject any Membership Agreement based upon the membership requirements and restrictions stated in the then current Bylaws. By signing below, the individual executing this Agreement on behalf of Applicant warrants that he or she has all requisite signing authority for and on behalf of the entity seeking membership. In the event that TCG does not accept an Applicant for membership, the Applicant's fee payment sent as part of such application shall be immediately refunded to Applicant.

The term of membership shall be on a calendar-year basis, expiring on December 31st of each year. A new member’s first year of membership fees will be pro-rated according to the quarter in which the new member joined. TCG will invoice Members 90 days prior to the expiration of the pending term and a Member’s payment thereof shall constitute a renewal of Membership. Failure to make a timely renewal payment shall be cause for suspension and termination of membership and member benefits.

The undersigned agrees that once accepted, all membership fees are non-refundable for any reason, including termination of membership. There is no duty to renew any Membership and renewal may only be accomplished as set forth above.
